ORGANIC WASTE YES

Confer inside a container, in the biodegradable and compostable envelope. Fruits, vegetables, eggs, fish and its residues, crustaceans, mussel shells, clams etc., meat and small bones, bread, pasta, rice, remains of food, kitchen waste, and spoiled food, coffee grounds, tea and chamomile filters, used napkins and paper towels, waste and litter from small domestic animals (if compostable, from clay, sawdust, shavings, natural sand or paper). Small amounts of plant residue and cut flowers, extinguished ashes of fireplaces.

ORGANIC WASTE NO

Nappies, tampons, rags even if wet, containers for pizzas, wrappers with food residues (eg butchery, peaches rie, rosticcerie, etc.), excrement of farm animals (eg rabbits, hens, etc.). Animal litter household composed of synthetic sand. **RESIDUAL WASTE YES**

Casings with food residues (e.g. butchers, fish shops, rotisseries, etc.).

Rubber, music cassettes, video cassettes, Cds and Dvds, plastic cutlery, pens, small plastic and bakelite objects, hair accessories and accessories for personal hygiene (e.g. toothbrushes for teeth, hair brushes and combs, pliers, clips, etc.), carbon paper, plasticised paper, baking paper, nylon stockings, Sacks, reusable rags, dressing pads, plasters and syringes, nappies, tampons, used toilet paper, cosmetics, poultry feathers, pet litter composed of sand of syntetic origin. Ceramic plates, cups and cups and shards in general, broken mirrors. Dust of the vacuum cleaner and household cleaning, small objects in painted wood, small plastic articles, cigarette butts, chewing gum. (If rags, footwear or clothing are not reusable anymore, a sign shall be placed on the codend stating: "CLOTHES WHICH CANNOT BE REUSED"). All articles consisting of more than one material other than tetrapack where separation is not possible. **RESIDUAL WASTE NO**

Pizza boxes, tetrapak containers, plastic bags, shopping bags, quick-frozen foods, pasta, chips, and other food in general. Anything that can be recycled! Calcined wastes, cement sacks, toxic bins, cans containing residues of all kinds (e.g. glues, solvents, varnishes, resins, etc.), industrial and agricultural residues, agricultural containers containing pesticides, fertilizers and fertilizers, pvc pipes for irrigation, tyres, inner tubes, car batteries and filters, engine oil and lubricants in general and any other parts of passenger cars, and motorcycles, fixtures and doors, sanitary ware, baths, radiators, plumbing, taps, electrical equipment, boilers, gates, railings, toner.

PLASTIC YES

Plastic water bottles, juices, milk, yogurt containers, cheese creams and desserts, pet food, containers for detergents and hygiene flasks rinse off. Bags, bags and containers for food, cellophane, brioches, chips, frozen foods, pasta, rice, meat and fish. Egg trays, polystyrene trays, nets for fruit and vegetables. Boxes for fruit and vegetables (1 piece for each day of collection per household). Clean cans and cans, plastic plates and glasses. Hangers clothes hanger and polystyrene of small packaging.

Televisions or computers, pirex (such as oven pyrotechnics), glass doors and windows. ALUMINIUM NO

Iron, paint cans. It is absolutely forbidden to give the glassaluminum funnel.

BULKY YES. NOT MORE THAN 5 PIECES AT A TIME Washing machines, dishwashers, refrigerators, televisions, computers, printers, video recorders, electric ovens, hi-fi, bed bases and mattresses, armchairs and sofas, old furniture, small appliances (telephones, mobile phones, blenders, toasters, coffee makers, toys), pallets, wood materials in general. To use the pick-up service bulky at home, (max 5 pieces at a time), you must book via toll-free number 800.069.960 (only from fixed network),or 070/684415 (from fixed and mobile network) active from 9.00 to 13.00 on Monday, Wednesday and Friday. From 9.00 to 14.00 on Tuesday, Thursday and Saturday. Alternatively, such a request may be forwarded also via the website to the address ingombranti@cosir.org. Entering the following data: Surname and first name of the person who is booking, surname and name of the TARI holder, telephone number, email address, municipality where to pick up, street and house number, type and quantity of waste to be collected.

BULKY NO

Calcined wastes, cement sacks, toxic bins, cans containing residues of all kinds (e.g. glues, solvents, varnishes, resins,

etc.), industrial and agricultural residues, agricultural containers with pesticides, fertilizers and fertilizers, pvc pipes for irrigation, tyres, air chambers, car batteries and filters, engine oil and lubricants in general and any other parts of cars and motorcycles, paper and cardboard, fixtures and doors, sanitary fixtures, baths, radiators, plumbing pipes, electrical equipment materials, gates, railings, toner.

T E/O F PHARMACEUTICAL BATTERIES

T E/O F: Wastes labelled T and/or F (T= toxic; F= flammable). Toxic/ noxious products are all those with compulsory the specific symbology so that they can be easily identified and recognized, thus using them for the specifications what a necessity.

PRIMARY CELLS: Zinc carbon cells (e.g. remote controls), Alkaline manganese cells (e.g. cameras, walkmen, mobile phones), Lithium batteries L91/FR-1,5 volts (e.g., laptops, cd players, cameras).

DRUGS: Separate the boxes and instructions that are to be given in the paper container

HOW TO GIVE T E/O F BATTERIES AND DRUGS?

Deliver hazardous waste (batteries, drugs, T and/or F labelled goods) exclusively in the appropriate containers located near the pharmacies and shops. Separate the various types of waste by giving them in the appropriate

PLASTIC NO

Toys, music cassettes, Cds and video cassettes, plastic cutlery, hair accessories and personal hygiene accessories (e.g. toothbrushes for teeth, hair brushes and combs, pliers, clips, etc.), laundry baskets, car components and accessories, pvc pipes for irrigation, containers or cans containing residues of any kind (e.g. glues, solvents, varnishes, resins, etc.) and any compo Plexiglass and polyethylene, all packaging consisting of more than one material from which separation is possible.

PAPER/PAPERBOARD YES

Newspapers, magazines, advertising leaflets, cardboard boxes, food boxes (e.g. rice, pasta, sugar, etc.), photocopying paper used, books and notebooks, tetrapak containers (eg milk brick, fruit juice, tomato sauce, etc.). Cartons for pizza. **NO PAPER/PAPERBOARD**

Nylon, cellophane, oiled paper, used toilet paper, towels, charcoal paper, parchment, dirty paper, paper napkins used, plasticized paper and paperboard, cement sacks. all packagings of more than one material, excluding tetrapack, from which separation is impossible.

GLASS YES

Bottles, carboys, bottles, vases, glasses and jars of glass.

ALUMINIUM YES Beverage cans, food trays, foil (e.g. yogurt lids), food boxes (tuna, meat, fish, legumes, peeled tomatoes), trays (for sweets, frozen foods and various foods), tubes (tomato concentrate, mayonnaise, anchovy paste), cosmetic tubes, aluminum caps and capsules, cream spray cans, deodorants, lacquers, shaving foam. Give glass and aluminum inside the same container, provided that it is not open on the bottom. It is forbidden to use fruit boxes in plastic for the delivery of such waste.

GLASS NO

Ceramic and porcelain objects, light bulbs, neon lamps, mirrors, screen glass, opal glass (e.g., perfume flasks), screens

containers. It is forbidden

absolute insertion inside the containers of all other types of collection. DIAPERS CLOTH AND SLEEPERS

Diapers, cloths and sleepers belong to the category of undifferentiated dry waste. Such waste will be collected, in addition to the day dedicated to the storage of dry undifferentiated, in a suplettivo day. To confer the diapers cloths and sleepers the user must make an explicit request to its municipality. The user is entitled to this service of collection if in his residence is presen you: a child under two years of age or an elderly person forced to use cloths/-sleepers and any subject to particular infirmity. The waste produced will be collected by operators on days and times established prior to exposure inside undifferentiated bags.
